

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.hpadvisors.com and Hinrichs+Pesavento LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Hinrichs+Pesavento LLC include www.hpadvisors.com and H+P Advisors. The H+P Advisors website is a accountant site. By using the H+P Advisors website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, H+P Advisors may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- IP Addresses
- Website Activity

H+P Advisors may also collect anonymous demographic information, which is not unique to you, such as your:

Use of your Personal Information

Sharing Information with Third Parties

Tracking User Behavior

Automatically Collected Information
